It is very important to know what it is necessary to declare or reveal on an official CBP declaration form (informally called the "customs form") before re-entering the country by plane or by ship. It can be reported foreign currency in the United States, but it is necessary to declare all the monetary instruments including Travelers' Cheque, mailboxes, gold coins, cash, checks, bills, titles or actions. There is no limit to the amount of money that can be brought beyond the United States border, but if you have more than \$ 10,000 it is necessary to report it to the CBP on the declaration form [Source: US Customs and Border Protection] Otherwise, all what you didn't have when you left the country must be declared, including: everything has been purchased (even from duty-free shops or on a ship or plane) everything that is inherited or received as a gift (you will be estranged the fair price market) all that has taken home for a friend anything you plan to use or sell in your business alterations or repairs to everything you took abroad and brought back (for example, tailoring of a dress a Hong Kong) all that has purchased (or received as a gift) in an insular country possession (America Samoa, Guam, the American Virgin Islands) or in any Caribbean country Basin Initiative (see the sidebar) and which is sent directly Ente at your home (this is different from the usual procedure for shipped items) All this means that you should save sales receipts (no matter what language or currency) in case you are asked to produce them and that you should Pack The elements you are declaring separately (perhaps in a hand luggage) in case the officials want to see them. You declare these entries by filling out the customs of the United States form you will receive by plane or at the airport before arriving at the customs area. The form, which also requires basic information related to your trip, requires listing each element in the list above and how much it costs. If you are traveling with your immediate family, personal exemptions can be combined on a form [Source: custom customs and border protection]. Abstract: CBP Form 6059B, customs declaration, is used as a standard identity report and residence of each person who arrives in the United States. This module is also used to declare articles imported from United States Customs and Border Protection (CBP) in accordance with 19 CFR 122.27, 148.12, 148.13, 148.110, 148,111; 31 u.s.C. 5316 and Section 498 of the ACT tariff of 1930, as amended (19 u.s.C. 1498). Section 148.13 of the CBP regulations requires the use of the CBP 6059B module when a written statement is required of a traveler to enter the United States. In general, written statements are requested by travelers who arrive by plane or by sea. Section 148.12 requires verbal statements from travelers entering the United States, unless a control agent requires a written declaration on the CBP module 6059b. In general, verbal statements are requested from travelers who arrive by land. CBP continues to find ways to improve the entry process through the use of mobile technology to make sure it is safe and efficient. This process, called Mobile Passport Control (MPC), which is a mobile app that allows self-segment travelers upon arrival in the States States e a process known also as the intelligent queue. The presentation of information in advance using MPC allows CBP for travelers to the appropriate queue in primary or self-segment directly to the secondary, if the additional inspection is necessary. The continuous experimentation also helps determine in which CBP circumstances should request a written customs declaration (CBP Form 6059b) and when it is advantageous to admit travelers who make an oral customs statement during primary inspection. MPC eliminates the Administrative carries out by the official during a traditional inspection and in most cases eliminating the need for respondents / travelers to fill out a declaration of paper. MPC provides more efficient and secure person inspection between the CBP Officer and the Traveler. Another other Process that CBP is testing to replace CBP Chart Module 6059B is the automated control passport (APC). It is a CBP program that facilitates the process of entry for travelers, providing self-service kiosks in the primary control area of the CBP that travelers can use to make their statement. Both APC and MPC allow an electronic method for travelers to answer questions that appear on the CBP module 6059B without compiling a paper module.
