In Illinois, the betting law dictates that you must be aged over 21 and be located inside state lines to place a sports wager legally. To prove you are in the state you must allow location setting on your device. This geolocation software can occasionally cause problems, but you can read our guide to fixing geolocation problems here. Additionally, you do not have to be a permanent resident of Illinois to bet.Illinois gambling laws meant that to wager online in the state, you needed to register an account at a casino before being able to bet online. Due to the ongoing pandemic, this need for remote registration has been suspended. This means customers can now download a betting app, sign up and wager, without the need to visit a casino. You can read more about remote registration on our news blog.There are some restrictions you should be aware of when betting in Illinois. First, you cannot bet on in-state collegiate teams. This means Illinois residents cannot wager on the University of Illinois or Northwestern if they are in their home state.Any bets placed must also be on sporting events only. You cannot bet on awards or elections. Finally, if you are involved in a sports league as a player, coach, or other personnel, you can't bet on your own sport. Other sports, however, are permitted.There are also numerous offshore websites offering Illinois sports gambling options. The state has not regulated these, so your information is not protected. It is a rare event for the teams to actually meet; however, that does not diminish the intense rivalry they share. Betting is not unfamiliar with Chicago residents, as DraftKings agreed to a deal with the Chicago Cubs to launch a DraftKings sportsbook at Wrigley Field.Betting on baseball is somewhat unique. Because the game is low scoring, Illinois sportsbooks will use what is known as a run line. This will set the spread at 1.5 runs, but the payout will be changed to appear more like a moneyline than a true spread bet.NBA Betting in IllinoisOne of the teams to rival the Chicago Bears' popularity in Illinois is undoubtedly the Chicago Bulls. Hockey is traditionally a low scoring game, so it is tricky for Illinois online sportsbooks who want to create a spread bet. If you wish to bet on the NHL, you can use a wager known as the puck line.
